

JDRF Promise Ball Gala Raffle Law (Jeep Wrangler Raffle)
November 10, 2018

ELIGIBILITY Original entries are entries purchased directly from the JDRF or its representative or Tempe Dodge Chrysler Jeep Ram benefiting the JDRF Arizona Chapter (the "Raffle"). Original entry purchaser must be either a business entity or an individual twenty-one (21) years of age or older at time of entry purchase. Individuals purchasing an entry on behalf of a business/legal entity must be legal representatives of the business/legal entity and must, themselves be twenty-one (21) years of age or older at the time of entry purchase. It is not necessary that an entry purchaser be a resident of the state of Arizona. Only one (1) individual may be identified as an entry purchaser. All federal, state and local laws and regulations apply. The Raffle is void where prohibited. The Raffle is conducted in English. Entries may be purchased via the internet, call center or at designated drop off center(s). Keep the tear off portion of the raffle ticket as confirmation of entry into the drawing. A hardcopy ticket confirmation number is not required to claim a prize. Questions concerning ticket confirmation number(s) should be directed to the "Administrator," JDRF Arizona Chapter at the address listed below. All entries are non-refundable. In the Raffle, there is no possibility of a tie. The raffle draw will be under the supervision of the Administrator. All time references to time are Mountain Standard Time. By entering the Raffle, the entry purchaser acknowledges that he or she is aware of, and agrees to abide by, the Raffle's Rules and Regulations. The following individuals and their respective affiliates, subsidiaries, parent and related companies and agencies are not eligible to win a prize in the Raffle: (a) staff of JDRF Arizona Chapter or immediate family members residing in the same household.

DRAWING Only 1,000 tickets will be sold at two price points: single tickets for \$100 and 6-pack for \$500. Entries received after the drawing takes place will be returned to the requesting entrant. The drawing will be held during the JDRF Promise Ball Gala on Saturday, November 10, 2018. The winner will be announced on Saturday, November 10th but need not be present to win. Winner will be notified Saturday, November 10th by phone or email.

ODDS 1/1000: 1 prize will be awarded – a 2018 Jeep Wrangler Unlimited Sport 4x4 Hard Top, 5-speed Automatic transmission with A/C in color Chief Clear Coat. Jeep Wrangler awarded may not be exactly as shown in the brochure, in television commercials or on the website, and are based on prize suppliers' availability. If unavailable, similar or like prizes may be substituted at the sole discretion of JDRF Arizona Chapter director of the Raffle. The approximate retail value of the prize is \$29,900 based on pricing at the time of prize selection. All MSRPs are rounded to the nearest dollar. The Jeep Wrangler may NOT be exchanged for cash. The winner is solely responsible for all taxes, license and fees associated with the prize. With proper transfer or sales documents bearing notarized signatures, as required by the Raffle, a prize may be transferred or sold. Prizes may also be donated back to JDRF Arizona Chapter.

NOTIFICATION OF WINNER The winner will be notified via phone, mail or by email (where available) by the Administrator of the requisite procedure to claim the prize. Winner of vehicle is required to claim their prize within twenty-one (21) calendar days of the draw. Vehicle winner shall be responsible for any and all state or local license, title, registration, documentation and prep fees associated with the vehicles. The name of prize winner will be available on the website. If a selected winner is unable to be contacted or located using the information provided with the entry prior to the deadline for claiming the prize, that prize will revert to JDRF Arizona Chapter. In the event a winning entry has more than one name listed on the ticket, the Administrator, JDRF Arizona Chapter will physically award the prize to the first name listed on the entry. Neither JDRF Arizona Chapter nor their legal counsel are responsible for resolving disputes that may arise from any conflict between or among joint ticket holders or purchasers.

PRIVACY By entering the Raffle, entry purchasers agree that their contact information provided in connection with the Raffle entry may be used for communications promoting the Raffle and future raffles sponsored by or conducted for the benefit of JDRF Arizona Chapter. An entry purchaser may subsequently "opt-out" of the receipt of such communications by following the directions in any email, other communication, or by contacting customer service (contact information below). Other than as provided herein, an entry purchaser's information will not be shared with or sold to any other person or entity. Purchase of an entry in the Raffle constitutes permission for the Raffle, JDRF Arizona Chapter, to publish winner's name, location (city and state), and prize won for purposes of advertising the Raffle or future raffles without further consent or compensation, unless prohibited by law.

REQUIREMENTS Winner must be an individual twenty-one (21) years of age or older at time of entry purchase or a business entity represented and authorized by someone at least twenty-one (21) years of age or older at the time of entry purchase.

WAIVER/LIMITATIONS OF LIABILITY Entry purchasers, by participating (and winner, by accepting a prize), release JDRF Arizona Chapter, and their respective parent companies, affiliates, partners, subsidiaries, agents, representatives, sponsors, service agencies and independent contractors, and each of their respective directors, officers, partners, employees and agents, including advertising and promotion agencies, from any and all liability with respect to participation in the promotion, possession, use and distribution of the prize awarded.

INTERNET The Raffle will pursue all available legal remedies against any individual(s) damaging or attempting to damage any JDRF Promise Ball Gala Jeep Raffle benefiting JDRF Arizona Chapter website or attempting to undermine the lawful operation of the Raffle.

TAXES AND IRS RULES All winner shall be responsible for any and all federal, state and local income or excise taxes, fees, assessments and like charges associated with the prizes. Winner is responsible for any transportation costs associated with transporting the vehicle to winner's location.

SPECIAL NOTE: At the time of this printing, federal law requires that corresponding tax withholding on prize values in excess of \$5,000.00 must be collected from winner upon award and distribution. Federal and state withholding laws are subject to change without notice. The withholding laws in effect at the time prizes are claimed will be followed. The IRS has taken the position that amounts paid for chances to participate in raffles, lotteries or similar programs are not gifts and, therefore, the price of the entry does not qualify as a deductible charitable contribution.
