

## COVID-19 PROTOCOL

At JDRF, protecting the health and safety of our guests, donors, volunteers and staff remains a top priority as we prepare to come together in person to advance the mission we all share. For this reason, we are requiring all attendees and volunteers to provide proof of vaccination or a negative COVID test prior to attending the JDRF fall event.

We look forward to providing a positive experience for all event attendees. To help with that, please come prepared to show one of the following during the event check-in process:

- An official, government-issued vaccination card listing the guest's name and dates the last dose was administered
- A photo or digital version of an official government-issued vaccination card listing the guest's name and dates the last dose was administered
- A printed or digital negative COVID-19 PCR or antigen test (rapid test) administered by a healthcare professional with 72 hours to a guest's given event that includes the guest's name and date the last test was administered

## Policy and Process:

**How do I show proof of my vaccination status or negative COVID-19 test result?** Upon entry to JDRF fall event one of the following will be required:

- An official, government-issued vaccination card listing the guest's name and date the last dose was administered.
- A photo or digital version of an official government-issued vaccination card listing the guest's name and date the last dose was administered.
- A printed or digital negative COVID-19 PCR or antigen (rapid) test administered by a healthcare professional with 72 hours to a guest's given event that includes the guest's name and date the last test was administered.

**What does full vaccination mean?**

As advised by the CDC, a person is considered fully vaccinated against COVID-19:

- 2 weeks after their second dose in a two-dose series, such as Pfizer-BioNtech or Moderna vaccines, or
- 2 weeks after a single-dose vaccine such as Johnson & Johnson's vaccine

**What vaccines will be accepted?**

JDRF will accept the Pfizer-BioNtech, Moderna, Johnson & Johnson vaccine or other COVID-19 vaccines approved by the World Health Organization (WHO).

**What if I lost my vaccine card?**

It is recommended that you contact your doctor, clinic, pharmacy, or location where you were vaccinated to retrieve a new card.

**I have a religious or medical exemption for vaccines. Do I still have to provide proof of a negative COVID-19 test result?** Yes, all guests who cannot provide proof of vaccination must present a negative COVID-19 PCR or antigen (rapid) test administered by a healthcare professional within 72 hours of the event date.

**What if I'm not fully vaccinated but I started the process?** If you are not fully vaccinated (as defined in the Key Messages above), a negative COVID-19 PCR or antigen (rapid) test administered by a healthcare professional within 72 hours prior to a guest's given event date that includes the guest's name and the date of test is required.

**What if I recently had COVID-19 and are not yet eligible to start the vaccination process?** Proof of a negative COVID-19 PCR or antigen (rapid) test administered by a healthcare professional within 72 hours of the event date is required.

**What does this mean for youth ambassadors and children under 12?**

Youth ambassadors must either meet the requirements to be considered fully vaccinated or show proof of a negative COVID-19 PCR or antigen (rapid) test administered by a healthcare professional taken within 72 hours of the event date. Children under 12 will need proof of a negative COVID-19 PCR or antigen (rapid) test administered by a healthcare professional taken within 72 hours of the event date. It is also recommended that unvaccinated children wear masks. Please follow your state and local guidance on the use of masks.

## **COVID-19 Testing:**

**What types of tests do you accept?** A printed or digital negative COVID-19 PCR or antigen (rapid) test administered by a healthcare professional within 72 hours prior to a guest's given event date that includes the guest's name and the date of test is required.

**Will self-administered or at-home COVID-19 tests be accepted as negative proof?** No, only a COVID-19 PCR or antigen (rapid) test administered by a healthcare professional within 72 hours prior to a guest's given event date that includes the guest's name and the date of test will be accepted.

**Will JDRF have testing available on site?** No, testing opportunities will not be available for event attendees on site. Prior to arrival at the event, guests should have their negative COVID-19 results completed and in hand.

**When should I get tested?** Attendees must have a negative result COVID-19 PCR or antigen (rapid) test administered by a healthcare professional within 72 hours of the event date.

- Example: For events taking place on a Saturday, negative results from tests administered on the Wednesday, Thursday, or Friday prior to the event or tests administered on the day of the event will be accepted.
