WHAT IS TYPE ONE DIABETES (T1D)?

Type 1 diabetes (T1D) is an autoimmune disease in which a person's pancreas stops producing insulin, a hormone people need to get energy from food. T1D strikes both children and adults, and its onset has nothing to do with diet or lifestyle. By 2050, it is estimated that there will be nearly 600,000 youths with T1D in the U. S. There is currently nothing you can do to prevent it, and there is no cure.
